#### **Service Department**

- Received and completed 6,734 service calls in 2013
- Cleaned 26.2 miles of storm and sanitary sewer
- Filmed 10.1 miles of storm and sanitary sewer
- Located and repaired 391 storm and sanitary tees to facilitate sewer maintenance
- Collected 7,897 tons of recycling
- Sold almost 10,200 cubic yards of mulch and humus
- Swept over 1,300 miles of streets resulting in 427 tons of debris

- Over \$20,000 in Emergency Food Distributions











## OBJECTIVE:CONTROL COSTS GENERAL FUND OPERATING REVENUE VS. EXPENDITURES (MILLIONS)




**SOURCES OF GENERAL FUND REVENUE (ACTUAL 2013)** 






#### **GENERAL FUND COMPARATIVE OPERATING EXPENDITURES (MILLIONS)**




## OBJECTIVE: CONTROL COSTS GENERAL FUND EXPENDITURES – BY DEPARTMENT (2013)


