# WESTLAKE CITY COUNCIL MEETING JUNE 19, 2014 PROCEEDINGS OF PUBLIC HEARINGS AND A REGULAR SESSION

Public hearing was called to order by President of Council Michael F. Killeen at 8:00 p.m. in accordance with Article III, Section 13, of the Westlake City Charter and legal notice published in the West Life on June 11, 2014, and June 18, 2014, regarding the following legislation:

ORDINANCE NO. 2014-34: AN ORDINANCE PROVIDING FOR THE AMENDMENT

OF THE ZONE MAP OF THE CITY OF WESTLAKE,

WHICH ZONE MAP IS PART OF THE ZONING CODE OF THE CITY OF WESTLAKE, BY CHANGING THE ZONING OF CERTAIN LAND LOCATED ON THE EAST SIDE OF CROCKER ROAD AND THE SOUTH SIDE OF CENTER RIDGE ROAD, BEING PART OF PERMANENT PARCEL

NOS. 217-28-004 AND 217-28-006, FROM R-1F-80 DISTRICT TO OFFICE BUILDING DISTRICT.

Planning Director Jim Bedell explained this amendment to the zoning code.
