WESTLAKE CITY COUNCIL MEETING PROCEEDINGS OF A REGULAR SESSION OCTOBER 1, 2015

The regular session of Council was called to order at 8:00 p.m. by President of Council Pro Tem Kenneth R. Brady.

Communication from Mayor Clough dated September 28, 2015, requesting authorization to purchase signal repair services from Signal Service Company, Inc., in an amount not to exceed \$90,000.00 for the 2015 calendar year. (Ordinance No. 2015-123)

Communication from Director of Recreation Bob DeMinico dated September 25, 2015, stating that at the September 15, 2015, Recreation Commission meeting, the commission recommended an increase to the Recreation Center membership fees and daily admission for non-residents for 2016. Council took no action, therefore these rates will automatically go into effect 60 days from the date of passage by the Recreation Commission.

PETITIONS FROM THE PUBLIC:

Robert Koenig, 29181 Schwartz Road, commented on the repair work on Schwartz Road, the amount of sealant used for cracks in the road, and what will be done to repair the pot holes. He was told to meet with the Engineering and Service directors to discuss this.
