WESTLAKE CITY COUNCIL MEETING PROCEEDINGS OF A REGULAR SESSION NOVEMBER 5, 2015

The regular session of Council was called to order at 8:04 p.m. by President of Council Michael F. Killeen.

COMMITTEE OF THE WHOLE:

President of Council Killeen reported on the Committee of the Whole meeting held this date at 7:32 p.m. Present were Councilmembers Killeen, Appel, Nunnari, Sullivan, O'Donnell, Brady, Getsay. Also present were Directors Wheeler, Quinn, Kelly, Shah, DeMinico, Bedell, Surber, Grayem, Gadd, Bielozer, Hughes and Clerk Rosenbaum. Agenda items were discussed as well as selected correspondence, appointing a member of Council to the Board of Review for an appeal of an assessment for city income tax, acknowledging the encouragement from Westside Christian Academy, and re-introducing an ordinance regarding feeding of deer. Also discussed was the procedure to obtain formal approval of expenditures anticipated to exceed \$25,000 with various vendors. In the future, it was requested that the administration simply provide notification and supporting documentation to Council to be read under selected correspondence at a Council meeting. An ordinance is no longer requested. The Clerk was instructed to provide a memo to the administration as to this procedure going forward. It was determined that action would be taken on such ordinances since they were already on the agenda. The following meeting was scheduled: Finance committee, December 5 at 8:30 a.m. for budget hearings.

ORDINANCE NO. 2015-121: (SECOND READING) AN ORDINANCE ALLOWING THE CITY AND PRIVATE CITIZENS TO MANAGE THE WHITE-TAILED DEER POPULATION WITHIN THE CITY OF WESTLAKE AND AMENDING SECTION 505.11 ENTITLED "HUNTING PROHIBITED," AND DECLARING AN EMERGENCY. (First reading 9/17/15.)

In the third Whereas clause, replace "...and the residents of the City with as many safe, effective, flexible and feasible tools as possible..." with "...with a deer management program..." In subsection 505.11(c), remove "...or any hunting equipment..." from the second sentence. From the third sentence, remove "...on property owned or managed by the City or, with the consent of the co-owners or co-managers, on property co-owned or co-managed by the City..." and insert "...on city-owned land and..." And in subsection 505.11(c)(2), replace "...law enforcement personnel selected..." with "...safety forces approved..."
