



CITY OF WESTLAKE, OHIO ORDINANCE NO. 2014-112:

> AN ORDINANCE AMENDING AND SUPPLEMENTING SUBSECTION 333.03(b) OF THE TRAFFIC CODE AS TO THE SPEED LIMIT ON A PORTION OF CROCKER ROAD.

WHEREAS, the Mayor has recommended that the speed limit on a portion of Crocker Road from Route 20 south to the Westlake corporation line be 45 miles per hour; and

WHEREAS, Council desires to amend and supplement the traffic code to provide for the same.

## NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WESTLAKE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

Section 1: That subsection (b) of Section 333.03 "Maximum Speed Limits; Assured Clear Distance Ahead" be amended and supplemented which as amended and supplemented shall read as follows:

## 333.03 MAXIMUM SPEED LIMITS; ASSURED CLEAR DISTANCE AHEAD.

(b) It is prima-facie lawful, in the absence of a lower declared or established pursuant to Ohio R.C. 4511.21 by the Ohio Director of Transportation or Council, for the operator of a motor vehicle to operate the same at a speed not exceeding the following:

(3) Thirty-five miles per hour on all State routes or through highways within the Municipality outside business districts, except as provided in the subsections (b)(4), (5) and (13), hereof;

(13) 45 miles per hour along Crocker Road from Route 20 south to the Westlake corporation line.

\* \* \*

<u>Section 2</u>: That it is found and determined that all formal actions of this Council concerning and relating to this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 10, Article XI of the Charter of the City of Westlake.

**Section 3:** That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.
