



**CITY OF WESTLAKE, OHIO  
ORDINANCE NO. 2014-125:**

**AN ORDINANCE AMENDING SECTION 169.02  
“ASSISTANT DIRECTOR” OF CHAPTER 169,  
“COMMUNITY SERVICES DEPARTMENT”,  
AND DECLARING AN EMERGENCY.**

**WHEREAS**, Council desires, at the recommendation of the Mayor and Director of Community Services, to amend the licensure requirements of the Assistant Director of Community Services.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WESTLAKE, COUNTY OF CUYAHOGA AND STATE OF OHIO:**

**Section 1:** That Section 169.02 “Assistant Director” of Chapter 169 “Community Services Department” shall be amended and as amended shall read as follows:

**“169.02 ASSISTANT DIRECTOR**

There is hereby established the position of Assistant Director, who shall be a full-time employee appointed by the Mayor. The Assistant Director shall be in the unclassified service of the City pursuant to Charter IV, Section 12.

The duties of the Assistant Director shall include assisting the Director of the Community Services Department in the professional and administrative functions of the Department. The Assistant Director shall perform the duties of the Director in his/her absence. The compensation to be paid to the Assistant Director shall be established by separate ordinance of Council. The Assistant Director shall perform other such duties as may be assigned by the Mayor and/or the Director of the Community Services Department.”

**Section 2:** That any Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

**Section 3:** That it is found and determined that all formal actions of this Council concerning and relating to this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 10, Article XI of the Charter of the City of Westlake.

**Section 4:** That this legislation is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, safety and welfare, and for the further reason that it is immediately necessary to amend Chapter 169 for the efficiency of operations in the Community Services Department, and further provided it receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor.
