



### CITY OF WESTLAKE, OHIO ORDINANCE NO. 2015-103:

AN ORDINANCE AMENDING SECTION 2 OF ORDINANCE NO. 2010-86 AS TO A CHANGE ORDER FOR THE GROUNDWATER QUALITY ASSESSMENT PLAN CONTRACT WITH EARTH CONSULTING, LTD., AND DECLARING AN EMERGENCY.

WHEREAS, by and through Ordinance No. 2010-86 as amended by Ordinance No. 2013-74, Council authorized and directed the Mayor to enter into a Professional Services Contract with Earth Consulting, Ltd., for a groundwater quality assessment plan at the former sanitary landfill; and

WHEREAS, the Mayor and the Director of Public Service have recommended that the cost of the services authorized in Ordinance No. 2010-86 be amended to provide for a change order for the continued response to the Ohio EPA, pursuant to the July 10, 2015 Proposal of Earth Consulting, Ltd., attached hereto as Exhibit "A".

# NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WESTLAKE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

Section 1: That Section 2 of Ordinance No. 2010-86 be and the same is hereby amended and as amended shall read as follows:

"<u>Section 2</u>: That the Director of Finance be and he hereby is authorized and directed to issue warrants to Earth Consulting, Ltd., in such amounts as approved by the Mayor at a cost not to exceed One Hundred Seventy-Seven Thousand Dollars and Zero Cents (\$177,000.00)."

Section 2: That any Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

Section 3: That it is found and determined that all formal actions of this Council concerning and relating to this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal

action were in meetings open to the public in compliance with all legal requirements including Section 10, Article XI of the Charter of the City of Westlake and Section 121.22 of the Ohio Revised Code.

<u>Section 4</u>: That this legislation is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, safety and welfare, and for the further reason that it is immediately necessary to continue the ground water quality assessment plan for the former sanitary landfill, and further provided it receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor.

Re: Update and Request for Change Order Groundwater Assessment Former Sanitary Landfill

Dear Mr. Stuhm:

This letter provides an update on the schedule and budget for the groundwater assessment program at the former landfill in the City of Westlake. As you are aware, as a result of the work completed to date, the Ohio EPA has indicated that a Groundwater Assessment report should now be prepared. This report is required when the OEPA feels that the nature and extent of any suspected contamination has been determined. Following the submission of the Groundwater Assessment report, the OEPA requires submission of a Corrective Measures Plan within 180 days. Thereafter, upon concurrence with the Corrective Measures Plan, the proposed corrective measures would be implemented.

The Groundwater Assessment report will summarize the work completed to date as part of the assessment activities. It will also include a thorough review of the analytical data collected as well groundwater flow characteristics. The conclusions of this report will summarize the results of these activities and suggest a possible remedial approach.

The Corrective Measures Plan will review in more detail the proposed remedies and based on that review, will recommend a remedy that is both cost-effective and protective of human health and the environment. At this time, it is likely that we will recommend a monitoring only remedial action.

After consultation with Mr. Eric VanHeyde at Mannik Smith Group, we are proposing the following schedule:

Groundwater Assessment Report

Submitted to OEPA by October 1, 2015

Corrective Measures Plan

Submitted to OEPA by December 30, 2015 comments on both reports which will have to be

Based on our experience, the OEPA will have comments on both reports which will have to be addressed. Given the review time required by the OEPA and the final approval process at the OEPA that the ultimate goal of the Corrective Measures Plan approval would likely come during the summer or fall of 2016.

We have review the existing budget for groundwater assessment activities. Based on that review, we anticipate that additional funds will need to be allocated to complete the assessment activities. As of today there is a balance of \$22,299.13 in contract 2010-86. The following charges are anticipated to be incurred between now and the time of completion:

•	2016 Groundwater sampling The goal is to have the Corrective Measures Plan approved prior to the fall 2016 groundwater sampling event
Groundwater Assessment Report	\$10,000
Corrective Measures Plan	\$10,000

Based on these anticipated costs, the schedule described herein and the remaining budget, we are requesting a change order approval in the amount of \$33,000.
