ORDINANCE NO. 2015-116:**

**AN ORDINANCE AMENDING APPROPRIATIONS  
FOR THE CITY OF WESTLAKE, OHIO**

WHEREAS, Section 5705.38 of the Ohio Revised Code provides that the Appropriation Ordinance may be amended or supplemented, and that transfers may be made from one appropriation to another, and

WHEREAS, this Council finds it necessary to supplement the appropriation ordinance by the appropriation of funds heretofore unappropriated, and transferring funds from one appropriation to another, and

WHEREAS, the Director of Finance is seeking the permission of Council to record this appropriation and the subsequent appropriated advances and transfers of funds into the financial records of the City of Westlake,

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WESTLAKE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

SECTION 1: That ordinance No. 2014-175 passed by this Council on December 18, 2014, ordinance No. 2015-15 passed by this Council on February 5, 2015, ordinance No. 2015-23 passed by this Council on February 19, 2015, ordinance No. 2015-34 passed by this Council on March 19, 2015, ordinance No. 2015-52 passed by this Council on April 16, 2015, ordinance No. 2015-61 passed by this Council on May 7, 2015, ordinance No. 2015-102 passed by this Council on July 16, 2015, and ordinance No. 2015-107 passed by this Council on September 3, 2015, be amended and as amended shall read as follows:

SECTION 2 That this ordinance and the subject matter thereof is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, and safety, and for the further reason it is necessary to provide additional funds to maintain certain departments for the continuity of the services they provide, and further provided it receives the affirmative vote of two thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor.

SECTION 3: That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 121.2 of the Ohio Revised Code.


