



**CITY OF WESTLAKE, OHIO  
ORDINANCE NO. 2015-117:**

**AN ORDINANCE AUTHORIZING THE  
MAYOR TO ENTER INTO AN AGREEMENT  
WITH BAILEY COMMUNICATIONS, INC.  
FOR CITY NETWORK SUPPORT SERVICES,  
AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Mayor and Director of Purchasing recommend that Council authorize the Mayor to enter into a 2015 Time and Materials Support Agreement with Bailey Communications, Inc. for City network support services; and

**WHEREAS**, the City already utilizes Bailey Communications, Inc. as network service provider for the Information Technology and Police Departments as well as for various other maintenance, technical and installation services necessary to maintain the City's network and support services; and

**WHEREAS**, the Mayor and Director of Purchasing recommend that Council authorize the Mayor to enter into a 2015 Time and Materials Support Agreement with Bailey Communications, Inc. for City network support services for the remainder of the 2015 calendar year.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF  
WESTLAKE, COUNTY OF CUYAHOGA AND STATE OF OHIO:**

**Section 1:** That the Mayor be and he is hereby authorized and directed to enter into Time and Materials Support Agreement with Bailey Communications, Inc. as to City network support services, which Agreement shall be kept on file in the Department of Purchasing in a form as approved by the Director of Law.

**Section 2:** That the Director of Finance be and he hereby is authorized and directed to issue warrants of the City of Westlake to Bailey Communications, Inc. for calendar year 2015 in a total amount not to exceed Sixty Thousand Dollars and Zero Cents (\$60,000.00), upon the approval of the Mayor.

**Section 3:** That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in

such formal action were in meetings open to the public in compliance with all legal requirements including Section 10, Article XI of the Charter of the City of Westlake and Section 121.22 of the Ohio Revised Code.

**Section 4:** That this Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, safety and welfare, and for the further reason that it is immediately necessary to provide for continuity of information technology and City network support and services, and further provided it receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be enforce immediately upon its passage and approval by the Mayor.
