



**CITY OF WESTLAKE, OHIO
ORDINANCE NO. 2015-126:**

**AN ORDINANCE AMENDING SECTION 2
OF ORDINANCE NO. 2015-44 AS TO
EXPENDITURES FOR PARTS AND
EQUIPMENT FROM MTECH COMPANY,
AND DECLARING AN EMERGENCY.**

WHEREAS, by and through Ordinance No. 2015-44, Council authorized the Mayor to purchase two (2) lateral cameras and to expend funds for various parts and equipment from MTech Company for the calendar year 2015; and

WHEREAS, the Mayor and Director of Purchasing have recommended that the amount of expenditures authorized in Ordinance No. 2015-44 be amended to provide for additional funds.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WESTLAKE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

Section 1: That Section 2 of Ordinance No. 2015-44 be and the same is hereby amended and as amended shall read as follows:

Section 2: That the Director of Finance be and he hereby is authorized and directed to issue warrants of the City of Westlake to MTech Company in a total amount not to exceed Forty Thousand Dollars and Zero Cents (\$40,000.00) for the calendar year 2015, upon the approval of the Mayor.”


Section 2: That any Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

Section 3: That it is found and determined that all formal actions of this Council concerning and relating to this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 10, Article XI of the Charter of the City of Westlake and Section 121.22 of the Ohio Revised Code.

Section 4: That this legislation is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, safety and welfare, and for the further reason that it is immediately necessary to continue the efficiency of the Engineering and Public Service Departments, and further provided it receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor.


