



**CITY OF WESTLAKE, OHIO  
ORDINANCE NO. 2015-133:**

**AN ORDINANCE AUTHORIZING A 2015  
PERSONAL SERVICES AGREEMENT WITH  
JACOB BARB FOR FITNESS CLASSES AT  
THE WESTLAKE RECREATION CENTER.**

**WHEREAS**, Council desires to authorize a 2015 Personal Services Agreement with Jacob Barb for FitPass by Jake classes at the Westlake Recreation Center for 2015; and

**WHEREAS**, the City collects the fees for the program from the participants and then retains a portion of the proceeds with the remainder given to the vendor; and

**WHEREAS**, this Contract is exempt from public bidding as a Personal Services Contract pursuant to Westlake Charter Article V, Section 5(b).

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WESTLAKE, COUNTY OF CUYAHOGA AND STATE OF OHIO:**

**Section 1:** That Council hereby authorizes a 2015 Personal Services Contract with Jacob Barb for FitPass by Jake classes in the Westlake Recreation Center in accordance with the Independent Contractor Agreement for Purchase of Services on file with the Director of Recreation.

**Section 2:** That the Director of Finance be and he hereby is authorized and directed to issue warrants of the City of Westlake to Jacob Barb in an amount not to exceed Thirty-Three Thousand Dollars and Zero Cents, (\$33,000.00).

**Section 3:** That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 10, Article XI of the Charter of the City of Westlake and Section 121.22 of the Ohio Revised Code.

**Section 4:** That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.




