



CITY OF WESTLAKE, OHIO ORDINANCE NO. 2015-134:

AN ORDINANCE AUTHORIZING THE MAYOR TO PURCHASE PRINTED MATERIALS FROM ALPHAGRAPHICS FOR THE 2015 CALENDAR YEAR, AND DECLARING AN EMERGENCY.

**WHEREAS**, the Mayor and Director of Purchasing recommend that Council authorize the Mayor to purchase printed materials from Alphagraphics for the 2015 calendar year; and

WHEREAS, Council desires to approve these expenditures with Alphagraphics for printed materials for the 2015 calendar year.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WESTLAKE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

<u>Section 1</u>: That the Mayor be and he is hereby authorized to purchase printed materials from Alphagraphics for the 2015 calendar year in an amount not to exceed Thirty Thousand Dollars and Zero Cents (\$30,000.00).

Section 2: That the Director of Finance be and he hereby is authorized and directed to issue warrants of The City of Westlake to Alphagraphics in a total amount not to exceed Thirty Thousand Dollars and Zero Cents (\$30,000.00), upon the approval of the Mayor.

Section 3: That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 10, Article XI of the Charter of the City of Westlake and Section 121.22 of the Ohio Revised Code.

Section 4: That this Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, safety and welfare, and for the further reason that it is immediately necessary to provide for the continuity and efficiency of City services by the various departments, and further provided it receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be enforce immediately upon its passage and approval by the Mayor.
