



**CITY OF WESTLAKE, OHIO
ORDINANCE NO. 2015-135:**

**AN ORDINANCE AUTHORIZING THE
MAYOR TO PURCHASE OFFICE SUPPLIES
AND RELATED ITEMS FROM KIKS OFFICE
PARTNERS FOR CALENDAR YEAR 2015,
AND DECLARING AN EMERGENCY.**

WHEREAS, the Mayor and the Director of Purchasing recommend that purchases from Kiks Office Partners for office supplies and related items in the amount of Thirty Thousand Dollars and Zero Cents (\$30,000.00) for calendar year 2015 be authorized by Council; and

WHEREAS, Council desires to authorize the Mayor to make said purchases from Kiks Office Partners for office supplies and related items.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WESTLAKE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

Section 1: That Council hereby authorizes the Mayor to purchase office supplies and related items from Kiks Office Partners in the amount of Thirty Thousand Dollars and Zero Cents (\$30,000.00) for calendar year 2015.

Section 2: That the Director of Finance be and he is hereby authorized to issue warrants of the City of Westlake in an amount not to exceed Thirty Thousand Dollars and Zero Cents (\$30,000.00) for calendar year 2015 to Kiks Office Partners upon the approval of the Mayor.

Section 3: That it is found and determined that all formal actions of this Council concerning and relating to this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 10, Article XI of the Charter of the City of Westlake and Section 121.22 of the Ohio Revised Code.

Section 4: That this legislation is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, safety and welfare, and for the further reason that it is immediately necessary to preserve the efficiency of the various Departments within the City, and further provided it receives the affirmative vote of two-thirds
