



**CITY OF WESTLAKE, OHIO
ORDINANCE NO. 2015-137:**

AN ORDINANCE AUTHORIZING THE MAYOR TO PURCHASE ONE (1) 1998 GMC T6500 CARGO VAN FROM FARBER SPECIALTY VEHICLES AND RELATED EQUIPMENT FROM VARIOUS VENDORS FOR A MOBILE COMMAND VEHICLE FOR THE POLICE DEPARTMENT, AND DECLARING AN EMERGENCY.

WHEREAS, the Police and Service Departments reviewed specifications and obtained quotations for the purchase and retrofitting of a command vehicle and related equipment; and

WHEREAS, this Council, by Ordinance No. 1987-50, authorized the Mayor, under the Ohio Cooperative Purchase Act, to purchase supplies, service equipment and materials, through participation in State Contracts with the Ohio Department of Administrative Services; and

WHEREAS, the Director of Purchasing has advised this Council that the City can purchase one (1) 1998 GMC T6500 Cargo Van needed for the Police Department and trade in a 2000 FL50 Squad through Farber Specialty Vehicles. Related equipment can be purchased from various suppliers through the General Services Administration (GSA) Cooperative Purchasing Program, State of Ohio Cooperative Purchasing Program and open source vendors.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WESTLAKE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

Section 1: That the Mayor be and hereby is authorized to purchase one (1) 1998 GMC T6500 Cargo Van needed for the Police Department from Farber Specialty Vehicles and related equipment for the Police Department through the General Services Administration (GSA) Cooperative Purchasing Program in accordance with the Federal contracts, through the State of Ohio, Department of Administrative Service – Office of Purchasing under the Ohio Cooperative Purchasing Act as provided through Ordinance 1987-50 at the prices provided in accordance with the State of Ohio Contracts, and through various open source suppliers as follows:

Section 2: That the Director of Finance be and he is hereby authorized and directed to issue warrants of the City of Westlake for said vehicle and related equipment to the suppliers listed in Section 1 above in an amount not to exceed the sum Forty-Eight Thousand Dollars and Zero Cents (\$48,000.00).

Section 3: That it is found and determined that all formal actions of this Council concerning and relating to this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 10, Article XI of the Charter of the City of Westlake and Section 121.22 of the Ohio Revised Code.

Section 4: That this legislation is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, safety and welfare, and for the further reason that it is immediately necessary to provide for the efficiency and continuation of services by the Police Department and further provided it receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor.


