



CITY OF WESTLAKE, OHIO ORDINANCE NO. 2015-141:

AN ORDINANCE AUTHORIZING THE MAYOR TO PURCHASE FOUR (4) NEW MODEL YEAR DODGE CHARGERS AND WITH SELECTED OPTIONS FOR THE POLICE DEPARTMENT THROUGH THE STATE OF OHIO COOPERATIVE PURCHASING PROGRAM, AND DECLARING AN EMERGENCY.

WHEREAS, this Council, by Ordinance No. 1987-50, authorized the Mayor, under the Ohio Cooperative Purchase Act, to purchase supplies, service equipment and materials, through participation in State Contracts with the Ohio Department of Administrative Services; and

WHEREAS, the Director of Purchasing has advised this Council that the City can purchase four (4) new model year Dodge Chargers with selected options, Contract No. RS900616, Index No. GDC050, Item 28151, needed for the Police Department through the State of Ohio Cooperative Purchasing Program.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WESTLAKE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

Section 1: That the Mayor be and he hereby is authorized to purchase four (4) Dodge Chargers with selected options, Contract No. RS900616, Index No. GDC050, Item 28151, for the Police Department through the State of Ohio, Department of Administrative Service – Office of Purchasing under the Ohio Cooperative Purchasing Act as provided through Ordinance 1987-50 at the prices provided in accordance with the State of Ohio contracts.

<u>Section 2</u>: That the Director of Finance be and he hereby is authorized and directed to issue warrants of the City of Westlake for said vehicles with selected options to the supplier listed above in an amount not to exceed the sum of Ninety-Eight Thousand Five Hundred Dollars and Zero Cents (\$98,500.00).

Section 3: That it is found and determined that all formal actions of this Council concerning and relating to this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 10, Article XI of the Charter of the City of Westlake and Section 121.22 of the Ohio Revised Code.

Section 4: That this legislation is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, safety and welfare, and for the further reason that it is immediately necessary to continue the efficiency of the Police Department, and further provided it receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor.
