



**CITY OF WESTLAKE, OHIO
RESOLUTION NO. 2015-149:**

**A RESOLUTION REQUESTING THE
FISCAL OFFICER OF CUYAHOGA
COUNTY TO ADVANCE FUNDS TO
THE CITY OF WESTLAKE, OHIO, AND
DECLARING AN EMERGENCY.**

WHEREAS, from time to time during the Fiscal year of 2016 before and subsequent to tax settlement dates, the City of Westlake will undoubtedly require funds for the continuity of necessary services, which funds are drawn from General Operating Funds; and

WHEREAS, this Council respectfully requests the Fiscal Officer of this County to advance such funds from property taxes and special assessments when available to the Director of Finance of this City and deduct such advances from funds due to the City but not then distributed.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WESTLAKE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

Section 1: That the Fiscal Officer of this County is respectfully requested to advance funds from property taxes and special assessments to the Director of Finance of this City and that the amount of such advance or advances be charged to the City of Westlake and deducted from funds due to this City, but not distributed.

Section 2: That the Clerk of Council be and she is hereby directed to certify a copy of this Resolution to the Fiscal Officer of Cuyahoga County, Ohio.

Section 3: That it is found and determined that all formal actions of this Council concerning and relating to this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 10, Article XI of the Charter of the City of Westlake and Section 121.22 of the Ohio Revised Code.

Section 4: That this Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, safety and welfare, and for the further reason that it is immediately necessary to obtain in advance funds for the orderly payment of current obligations to the City, and further provided it receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor.


