



CITY OF WESTLAKE, OHIO ORDINANCE NO. 2015-21:

AN ORDINANCE ACCEPTING A BID AND AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH PERRAM ELECTRIC, INC. FOR THE CITY WIDE TRAFFIC SIGNAL UPGRADE WITHIN THE CITY OF WESTLAKE, AND DECLARING AN EMERGENCY.

**WHEREAS,** pursuant to an advertisement, the City received three (3) bid proposals for the City Wide Traffic Signal Upgrade in the City of Westlake, pursuant to specifications on file in the office of the Director of Engineering; and

WHEREAS, after careful analysis of such bid proposal received, the Mayor and Director of Engineering have recommended that Council accept the bid proposal of Perram Electric, Inc. for the aforesaid upgrade; and

**WHEREAS**, this Council hereby finds and determines that the bid proposal of Perram Electric, Inc. is the lowest and best bid proposal for the aforesaid project; and

WHEREAS, this Council hereby accepts the bid of Perram Electric, Inc. and rejects all other bids.

## NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WESTLAKE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

<u>Section 1</u>: That this Council does hereby accept the bid of Perram Electric, Inc. for the City Wide Traffic Signal Upgrade in the City of Westlake in an amount of Four Million Eight Hundred Seventy-Seven Thousand Three Hundred Dollars and Zero Cents (\$4,877,300.00) and rejects all others.

Section 2: That the Mayor be and he hereby is authorized and directed to enter into a contract with Perram Electric, Inc., which contract shall be in accordance with the contract documents of file in the office of the Director of Engineering.

Section 3: That the Director of Finance be and he hereby is authorized and directed to issue warrants of the City of Westlake made payable to Perram Electric, Inc. in an amount not to exceed Four Million Eight Hundred Seventy-Seven Thousand Three Hundred Dollars and

Zero Cents (\$4,877,300.00) subject to all the terms and conditions as set forth in the aforesaid contract upon the approval of the Mayor.

Section 4: That it is found and determined that all formal actions of this Council concerning and relating to this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 10, Article XI of the Charter of the City of Westlake and Section 121.22 of the Ohio Revised Code.

<u>Section 5</u>: That this legislation is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, safety and welfare, and for the further reason that it is immediately necessary to provide for the City Wide Traffic Signal Upgrade within the City of Westlake, and further provided it receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor.
