



**CITY OF WESTLAKE, OHIO
ORDINANCE NO. 2015-42:**

**AN ORDINANCE AUTHORIZING
THE MAYOR TO PURCHASE ONE
(1) NEW BUICK ENCLAVE, AND
DECLARING AN EMERGENCY.**

WHEREAS, the Mayor and Director of Purchasing recommend that the City purchase one (1) New Current Model Year Buick Enclave with selected options and trade-in or sell the current vehicle; and

WHEREAS, this vehicle is not currently available through any Cooperative Purchasing Programs; and

WHEREAS, the Director of Purchasing has advised this Council that the City can purchase one (1) New Current Model Year Buick Enclave with selected options from Morris Buick GMC.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WESTLAKE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

Section 1: That the Mayor be and hereby is authorized to purchase one (1) New Current Model Year Buick Enclave with selected options, less trade-in allowance by seller or resale of old unit by City through GovDeals.com, from the supplier listed as follows:

SUPPLIER:	Morris Buick GMC 26100 Lorain Road North Olmsted, Ohio 44070
EQUIPMENT:	One (1) New Current Model Year Buick Enclave with selected options
TRADE-IN:	Trade-in allowance by seller or resale by City through GovDeals.com (minimum of -\$9,000.00)
PRICE:	Not to exceed \$40,000.00

Section 2: That the Director of Finance be and he hereby is authorized and directed to issue warrants of the City of Westlake for said vehicle to the supplier listed in Section 1 above in an amount not to exceed the sum of Forty Thousand Dollars and Zero Cents (\$40,000.00).

Section 3: That it is found and determined that all formal actions of this Council concerning and relating to this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in *such formal* action were in meetings open to the public in compliance with all legal requirements including Section 10, Article XI of the Charter of the City of Westlake and Section 121.22 of the Ohio Revised Code.

Section 4: That this legislation is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, safety and welfare, and for the further reason that it is immediately necessary to continue the efficiency of the Mayor's Office, and further provided it receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor.
