



CITY OF WESTLAKE, OHIO ORDINANCE NO. 2015-46:

AN ORDINANCE APPROVING EXPENDITURES WITH RUSH TRUCK CENTERS OF OHIO FOR INTERNATIONAL TRUCK PARTS, AND DECLARING AN EMERGENCY.

**WHEREAS**, the Mayor and the Director of Purchasing recommend that expenditures with Rush Truck Centers of Ohio in an amount not to exceed Thirty-Five Thousand Dollars and Zero Cents (\$35,000.00) be approved; and

**WHEREAS**, Council desires to approve these expenditures with Rush Truck Centers of Ohio for International truck parts.

## NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WESTLAKE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

<u>Section 1</u>: That Council hereby approves the expenditures with Rush Truck Centers of Ohio in an amount not to exceed Thirty-Five Thousand Dollars and Zero Cents (\$35,000.00) for International truck parts for the calendar year 2015.

<u>Section 2</u>: That the Director of Finance be and he is hereby authorized to issue warrants of the City of Westlake in an amount not to exceed Thirty-Five Thousand Dollars and Zero Cents (\$35,000.00) to Rush Truck Centers of Ohio upon the approval of the Mayor.

Section 3: That it is found and determined that all formal actions of this Council concerning and relating to this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 10, Article XI of the Charter of the City of Westlake and Section 121.22 of the Ohio Revised Code.

Section 4: That this legislation is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, safety and welfare, and for the further reason that it is immediately necessary to provide for the maintenance and upkeep of the City's heavy duty trucks used by various Departments and further provided it receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor.
