

CITY OF WESTLAKE, OHIO ORDINANCE NO. 2015-51:

AN ORDINANCE AMENDING SECTION 16 OF ORDINANCE NO. 2014-175 MAKING APPROPRIATIONS FOR THE CITY OF WESTLAKE, OHIO FOR CURRENT EXPENSES AND OTHER EXPENDITURES DURING THE FISCAL YEAR ENDING DECEMBER 31, 2015, AND DECLARING AN EMERGENCY.

WHEREAS, pursuant to section 5705.38 of the Revised Code of Ohio, it is possible for this Council to pass an Appropriation Ordinance for the fiscal year ending December 31, 2015.

WHEREAS, due to typographical errors in both the name and number of the intended appropriated fund, an amendment is necessary.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WESTLAKE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

Section 1: That Section 16 of Ordinance No. 2014-175 and the same is hereby amended and as amended shall read as follows:

SECTION 16: That there be appropriated from the CROCKER ROAD IMPROVEMENT FUND (420):

Transfer to Infrastructure Tax Fund (440):

\$250,332.28

Section 2: That any Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

Section 3: That it is found and determined that all formal actions of this Council concerning and relating to this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 10, Article XI of the Charter of the City of Westlake and Section 121.22 of the Ohio Revised Code.

Section 4: That this legislation is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, safety and welfare, and for the further reason that it is immediately necessary to continue the efficiency of the various
