



CITY OF WESTLAKE, OHIO ORDINANCE NO. 2015-72:

AN ORDINANCE AUTHORIZING THE MAYOR TO PURCHASE WATCH GUARD INCAR CAMERAS AND RELATED SERVICES, AND DECLARING AN EMERGENCY.

WHEREAS, the Director of Purchasing has advised this Council that the City can purchase eleven (11) Watch Guard In-Car Cameras and related services for use by the Police Department through the General Services Administration (GSA) Cooperative Purchasing Program, Contract No. GS-35F-0186P.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WESTLAKE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

Section 1: That the Mayor be and hereby is authorized to purchase the following Watch Guard In-Car Cameras and related services for the Police Department through the General Services Administration (GSA) Cooperative Purchasing Program, Contract No. GS-35F-0186P in accordance with the Federal contracts:

<u>Section 2</u>: That the Director of Finance be and he hereby is authorized and directed to issue warrants of the City of Westlake for said in-car cameras and related services to Computech International and Vasu Communications Inc. in an amount not to exceed the sum of Fifty-Five Thousand Dollars and Zero Cents (\$55,000.00).

Section 3: That it is found and determined that all formal actions of this Council concerning and relating to this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 10, Article XI of the Charter of the City of Westlake and Section 121.22 of the Ohio Revised Code.

<u>Section 4</u>: That this legislation is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, safety and welfare, and for the further reason that it is immediately necessary to fully equip police cruisers and continue the efficiency of the Police Department, and further provided it receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor.
