



CITY OF WESTLAKE, OHIO ORDINANCE NO. 2015-76:

AN ORDINANCE REPEALING SECTION 1216.03 FOOTNOTE (g), AMENDING SUBSECTION 1216.03(g)(14) AND SUPPLEMENTING SUBSECTION 1216.03(h) OF THE ZONING CODE AS TO SLEEP STUDY LABORATORIES.

WHEREAS, various provisions of the Zoning Code need repealed, amended and supplemented to provide for clarification on the permissible use of sleep study laboratories in the Hotel/Motel District; and

WHEREAS, after careful consideration, the Planning Commission of the City of Westlake, on the <u>list</u> day of <u>June</u>, 2015, recommended approval of the changes to the Zoning Code specified herein; and

WHEREAS, pursuant to the Charter of the City of Westlake, Article III, Section 13, Council held a public hearing concerning the proposed changes.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WESTLAKE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

<u>Section 1</u>: That footnote (g) of Section 1216.03 entitled "SCHEDULE OF PERMITTED BUILDINGS AND USES" of Chapter 1216 of the Zoning Code be and the same is hereby repealed.

Section 2: That Subsection 1216.03(g)(14) be and the same is hereby amended and as amended shall read as follows:

"1216.03 SCHEDULE OF PERMITTED BUILDINGS AND USES.

Section 3: That Subsection 1216.03(h) be and the same is hereby supplemented with the enactment of new subpart 1216.03(h)(22) which as enacted shall read as follows:
