



**CITY OF WESTLAKE, OHIO
ORDINANCE NO. 2015-79:**

**AN ORDINANCE GRANTING AN
ELECTRIC UTILITY EASEMENT TO THE
CLEVELAND ELECTRIC ILLUMINATING
COMPANY FOR THE INSTALLATION OF
ELECTRIC UTILITY FACILITIES IN THE
CITY OF WESTLAKE, AND DECLARING
AN EMERGENCY.**

WHEREAS, The Cleveland Electric Illuminating Company has requested the City of Westlake grant an Electric Utility Easement for the installation of electric utility facilities on property owned by the City of Westlake located along the west side of Crocker Road from Studio Way to American Boulevard; and

WHEREAS, this Council deems it to be in the best interest of the City to so grant the aforementioned Electric Utility Easement.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WESTLAKE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

Section 1: That this Council does hereby grant an Electric Utility Easement for the installation of electric utility facilities on the City of Westlake's property along the west side of Crocker Road from Studio Way to American Boulevard, which Easement Agreement shall be in a form acceptable by the Mayor and Director of Law and shall be kept on file in the office of the Director of Engineering, and further that the Mayor be and he is hereby authorized and directed to execute said Easement Agreement with The Cleveland Electric Illuminating Company on behalf of the City of Westlake.

Section 2: That it is found and determined that all formal actions of this Council concerning and relating to this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 10, Article XI of the Charter of the City of Westlake and Section 121.22 of the Ohio Revised Code.

Section 3: That this legislation is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, safety and welfare, and for the further reason that it is immediately necessary to grant an Electric Utility Easement to The Cleveland Electric Illuminating Company, and further provided it receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor.


