



**CITY OF WESTLAKE, OHIO  
ORDINANCE NO. 2015-86:**

**AN ORDINANCE AUTHORIZING THE  
MAYOR TO PURCHASE ONE (1) NEW  
FORD PICK-UP TRUCK THROUGH THE  
STATE OF OHIO COOPERATIVE  
PURCHASING PROGRAM, AND  
DECLARING AN EMERGENCY.**

**WHEREAS**, this Council, by Ordinance No. 1987-50, authorized the Mayor, under the Ohio Cooperative Purchase Act, to purchase supplies, service equipment and materials, through participation in State Contracts with the Ohio Department of Administrative Services; and

**WHEREAS**, the Director of Purchasing has advised this Council that the City can purchase one (1) New Current Model Year Ford F150 Crew Cab 4WD Pick-Up Truck with selected options, Contract No. RS903615, Index No. GDC093, Item No. 26925, needed for the Police Department through the State of Ohio Cooperative Purchasing Program from Middletown Ford, Inc.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WESTLAKE, COUNTY OF CUYAHOGA AND STATE OF OHIO:**

**Section 1:** That the Mayor be and hereby is authorized to purchase one (1) New Current Model Year Ford F150 Crew Cab 4WD Pick-Up Truck with selected options, Contract No. RS903615, Index No. GDC093, Item No. 26925, needed for the Police Department through the State of Ohio, Department of Administrative Service – Office of Purchasing under the Ohio Cooperative Purchasing Act as provided through Ordinance 1987-50 at the prices provided in accordance with the State of Ohio contracts from the supplier listed as follows:

**Section 2:** That the Director of Finance be and he hereby is authorized and directed to issue warrants of the City of Westlake for said vehicle to the supplier listed in Section 1 above in an amount not to exceed the sum of Twenty-Eight Thousand Two Hundred Fifty Dollars and Zero Cents (\$28,250.00).

**Section 3:** That it is found and determined that all formal actions of this Council concerning and relating to this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 10, Article XI of the Charter of the City of Westlake and Section 121.22 of the Ohio Revised Code.

**Section 4:** That this legislation is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, safety and welfare, and for the further reason that it is immediately necessary to continue the efficiency of the Police Department, and further provided it receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor.


