



CITY OF WESTLAKE, OHIO ORDINANCE NO. 2015-157:

AN ORDINANCE WAIVING THE COMPENSATION REDUCTION PROVISION OF SECTION 167.26(b) AS TO PERSONNEL IN THE FIRE DEPARTMENT, AND DECLARING AN EMERGENCY.

WHEREAS, Council desires to waive the compensation reduction provision in whole for three part-time positions within the Fire Department as permitted by Westlake Codified Ordinance Section 167.26(b).

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WESTLAKE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

<u>Section 1</u>: That the compensation reduction provision of Westlake Codified Ordinance Section 167.26(b) is hereby waived in whole for the following positions within the Fire Department:

- 1.) One part-time Fire Marshall; and
- 2.) Two part-time Fire Inspectors.

Section 2: That it is found and determined that all formal actions of this Council concerning and relating to this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 10, Article XI of the Charter of the City of Westlake and Section 121.22 of the Ohio Revised Code.

Section 3: That this legislation is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, safety and welfare, and for the further reason that it is immediately necessary to continue continuity of fire inspection services in the Fire Department, and further provided it receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor.
