



CITY OF WESTLAKE, OHIO ORDINANCE NO. 2015-83:

AN ORDINANCE SUPPLEMENTING SECTION 1218.03 BY THE ENACTMENT OF NEW SUBSECTION (h)(14) AS TO COMMERCIAL INDOOR FIRING RANGES IN EXCLUSIVE INDUSTRIAL.

WHEREAS, David Holtz has filed an application to amend the Zoning Code of the City of Westlake to allow commercial indoor firing ranges in the Exclusive Industrial District by enacting new subsection 1218.03(h)(14); and

WHEREAS, Council desires to supplement the Zoning Code pursuant to said application; and

WHEREAS, after careful consideration, the Planning Commission of the City of Westlake, on January 4, 2016, did not recommend approval of the changes of the Zoning Code herein specified as requested by this Council; and

WHEREAS, pursuant to Charter Article III, Section 13, Council provided for and held a public hearing on said Code amendment.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WESTLAKE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

<u>Section 1</u>: That Section 1218.03 entitled "SCHEDULE OF PERMITTED BUILDINGS AND USES" of Chapter 1218 of the Zoning Code be and the same is hereby supplemented by the enactment of new subsection (h)(14) which enacted shall read as follows:

"1218.03 SCHEDULE OF PERMITTED BUILDINGS AND USES.

The following schedule enumerates all main, conditional and accessory buildings and uses which are permitted in industrial districts.

Those buildings and uses which are permitted and regulated as main, conditional and accessory uses in a given industrial district are designated by an "M", "C", or "A", respectively, placed opposite the use and in the columns under the districts in which such use is permitted.
