**AN ORDINANCE AMENDING SECTION 152.05  
OF THE ADMINISTRATIVE CODE AS TO  
EMPLOYEES WITHIN THE DEPARTMENT  
OF RECREATION, AND DECLARING AN  
EMERGENCY.**

**WHEREAS**, Council desires upon the recommendation of the Mayor and the Director of Recreation to amend Section 152.05 of the Administrative Code as to employees within the Recreation Department.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WESTLAKE, COUNTY OF CUYAHOGA AND STATE OF OHIO:**

**Section 1:** That Section 152.05 "OTHER EMPLOYEES GENERALLY" be and the same is hereby amended and as amended shall read as follows:

"152.05 OTHER EMPLOYEES GENERALLY.

The Department of Recreation shall also employ the following personnel:

Program Coordinator

Cashier

Four Recreation Center Building Custodians

Front Desk Clerk

**Section 2:** That any Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

**Section 3:** That it is found and determined that all formal actions of this Council concerning and relating to this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 10, Article XI of the Charter of the City of Westlake and Section 121.22 of the Ohio Revised Code.

**Section 4:** That this legislation is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, safety and welfare, and for the further reason that it is immediately necessary to provide for continuity of services at the

Recreation Center and further provided it receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor.


