



**CITY OF WESTLAKE, OHIO
ORDINANCE NO. 2016-35:**

AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH DESIGN-BUILD SOLUTIONS, INC. FOR THE 2016 ROOF REHABILITATION PROJECT THROUGH THE U.S. COMMUNITIES GOVERNMENT PURCHASING ALLIANCE, AND DECLARING AN EMERGENCY.

WHEREAS, the Home Rule powers of the Ohio Constitution grant power to the City to participate in joint purchasing programs; and

WHEREAS, the U.S. Communities Government Purchasing Alliance is a non-profit instrument of the government that assists local and state agencies in reducing the costs of purchased goods through the purchasing power of public agencies nationwide through competitively solicited contracts; and

WHEREAS, this Council, by Ordinance No. 2016-1, has previously authorized the City to continue to participate in various governmental cooperative programs, including the U.S. Communities Government Purchasing Alliance; and

WHEREAS, the Mayor, the Director of Engineering and the Director of Purchasing have advised this Council that the City can enter into a contract with Design-Build Solutions, Inc. for the 2016 Roof Rehabilitation Project (Recreation Center, Police and Fire Stations Roofs) through the U.S. Communities Government Purchasing Alliance.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WESTLAKE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

Section 1: That the Mayor be and he is hereby authorized and directed to enter into a contract with Design-Build Solutions, Inc. for the 2016 Roof Rehabilitation Project (Recreation Center, Police and Fire Stations Roofs), which contract shall be kept on file in the Department of Engineering in a form as approved by the Director of Law.


Section 2: That the Director of Finance is hereby authorized and directed to issue warrants of the City of Westlake to Design-Build Solutions, Inc. in an amount not to exceed One Million One Hundred Sixty Thousand Dollars and Zero Cents (\$1,160,000.00), when approved by the Mayor and the Director of Engineering.

Section 3: That it is found and determined that all formal actions of this Council concerning and relating to this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including Section 10, Article XI of the Charter of the City of Westlake and Section 121.22 of the Ohio Revised Code.

Section 4: That this legislation is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, safety and welfare, and for the further reason that it is immediately necessary to begin the 2016 Roof Rehabilitation Project for the safety and efficient functioning of City facilities, and further provided it receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor.
