



**CITY OF WESTLAKE, OHIO  
ORDINANCE NO. 2016-8:**

**AN ORDINANCE AUTHORIZING THE  
EXPENDITURE OF FUNDS WITH  
BAILEY COMMUNICATIONS, INC. FOR  
THE CITY'S TECHNOLOGY NETWORK,  
AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Mayor and Director of Purchasing recommend that Council authorize the Mayor to enter into a 2016 Maintenance Agreement and a T&M Support Services Agreement with Bailey Communications, Inc. for the City network maintenance and support for the Information Technology and Police Departments; and

**WHEREAS**, the Mayor and Director of Purchasing do also hereby recommend that Council authorize additional expenditures outside the Maintenance & Support Agreements with Bailey Communications, Inc. for miscellaneous repairs as may be necessary to maintain the City's network and support services throughout the 2016 year.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF  
WESTLAKE, COUNTY OF CUYAHOGA AND STATE OF OHIO:**

**Section 1:** That the Mayor be and he is hereby authorized and directed to enter into a 2016 Maintenance Agreement and a 2016 T&M Support Services Agreement with Bailey Communications, Inc., which agreements shall be kept on file in the Departments of Purchasing and Finance in a form approved by the Director of Law. Further, he is hereby authorized to expend funds as necessary for miscellaneous repairs outside of the Maintenance & Support Agreements all in an amount not to exceed Eighty Thousand Dollars and Zero Cents (\$80,000.00).

**Section 2:** That the Director of Finance be and he hereby is authorized and directed to issue warrants of The City of Westlake to Bailey Communications, Inc., the total amount of which shall not to exceed Eighty Thousand Dollars and Zero Cents (\$80,000.00), upon the approval of the Mayor.

**Section 3:** That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in

such formal action were in meetings open to the public in compliance with all legal requirements including Section 10, Article XI of the Charter of the City of Westlake and Section 121.22 of the Ohio Revised Code.

**Section 4:** That this Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, safety and welfare, and for the further reason that it is immediately necessary to provide for continuity of services within the Information Technology and Police Departments, and further provided it receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be enforce immediately upon its passage and approval by the Mayor.
